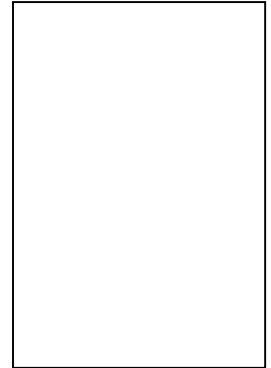

TERMS AND CONDITIONS

- 1) All the members of Women (SHGs) and Farmers Club/Group are eligible for achieving benefits in attainment of Agricultural Training and workshops, Procurement of Agricultural machinery and equipments and purchase of Tractors and other allied vehicles under **KRISHI VIKAS PROJECT** (under Govt. Scheme).
- 2) For procurements of Tractors under **KVP** all the members are advised to deposit the required documents in the office and amount in the Account of the “**CRO BHARAT FOUNDATION**” and this account shall be treated as Account of the Farmers Group.
- 3) All the members those who are procuring Agricultural Machinery, Tools, Equipments and Tractors shall be benefited with subsidies as per guidelines of the KVP.
- 4) All the members of the Women (SHGs) and Farmers Club/Group shall be provided the Tractor within 90(Ninety) days from the date of deposit of required documents and cost of the Tractor. In emergency or inability/disinterested of the farmers, the deposited amount by him/her will be return in his/her Bank Account within 45(Forty Five) days of the due cancellation.
- 5) The farmers are advised to submit the required documents towards mobilization and processing of releasing this Agricultural Machinery and equipments.
- 6) The Scheme under KVP is being initiated and motivated by Farmers Club/Group of CRO Bharat Foundation to provide training, workshops and easy accessibility of benefits of the Farmers.
